Buy American Act Compliance Information

- A. Products listed on SCHEDULE 1 are Commercially Available Off-the-Shelf ("COTS") items manufactured in the United States. The products listed on SCHEDULE 1 comply with the requirements of the Buy American Act and the American Recovery and Reinvestment Act without regard to the dollar value of the project.
- B. Products listed on SCHEDULE 2 are COTS items manufactured in Canada, which is a signatory to the World Trade Organization Government Procurement Agreement and the North American Free Trade Agreement. Provided the relevant dollar-value thresholds are met, the products listed on SCHEDULE 2 comply with the requirements of the Buy American Act and the American Recovery and Reinvestment Act and may be used on the following projects:

1. Federal Projects:

- a. Federal supply contracts that are under \$3,000, or \$25,000 or greater; and
- b. Federal construction contracts of \$7,804,000 or greater.

2. State, Local, and Quasi-Federal Projects:

- a. State and local construction projects that are not funded by the American Recovery and Reinvestment Act ("ARRA"); or
- b. ARRA-funded construction projects of \$7,804,000 or greater awarded by any of the entities identified in the February 9, 2010 Agreement on Government Procurement between the United States and Canada (http://edocket.access.gpo.gov/2010/pdf/2010-6548.pdf).
